



Copy forwarded to the Principals/Centre Superintendent of all Colleges/Examination Centres for information of all candidates of their respective institution and information of all other concerned with Annual Higher Secondary Examinations 2016. Principals are requested to make allotment of candidates among groups and conduct Practical Examination in such a manner that there is no overlapping of subject for any group. The grouping arrangement made by the Principal should be intimated to the External Examiners and Controller of Examinations at least two weeks before the commencement of Practical Examinations. The Practical Examinations are to be conducted only within the dates mentioned in this programme and of the fixed dates announced by the Principals. In case of violation of stipulated dates the Council reserves the right to withhold or cancel the result. Principals are also required to submit the Practical marks and Practical scripts in the Council within 10 (ten) days of completion of Practical Examinations. The Examiners of Practical Examination should submit the marks and scripts to the Principal as soon as the Practical Examination is over. In case the Principals do not get the marks/scripts within the stipulated period; they must intimate this to Council. Date of submission of valued scripts/marks etc of practical Examinations in the Head office shall be notified latter. All Principals / Headmasters/Headmistress are requested to circulate this programme well in advance in their respective institutions.

Further, it has come to the notice of the Council that letters mentioning dates of Practical Examinations to External Examiners appointed by the Council are not intimated by some Principals in time and other substitute External Examiners are appointed in their place. In the case of delay communication to the Original External Examiners and alternative arrangements by the Principal / Centre Superintendent will be seriously viewed and the Centre Superintendent will be held responsible for any action taken by the Council in this regard.
